Process on SCC Data/Information

- -We created an internal tracker that contains contact information for SEC, SCC, County Chairs, and Committees members. CD Chairs, Chair of Chair and Statewide Officers have access to this list to make edits to the tracker and to even update attendance for SCC meetings as members tell their CD Chair they can not attend a meeting.
 - -When approved users make edits, there will be a notification that pops up to ensure those edits are truly intentional because this document is a main list of contact information.
- -The NDP mostly communicates to SCC and SEC via the official listserves and phone and text rather than simply becing people on emails so we have record in a listserve of communications.
- -CD Chairs are given permission to communicate with their CDs via email and phone and text (please remember to BCC the email addresses by copying the emails from the tracker).
- -If anyone requests the list for NDP office campaign purposes (e.g. someone running for a NDP statewide officer position), they will get a PDF version of the list requested.
- -The Communications Director manages all listserves and anyone on the SCC can request to be on the listserves given they adhere to the listserve guidelines.

- Nominees for this award should be volunteers who personify the spirit of the Nebraska Democratic Party. The award is given to an individual who is tireless in supporting the Nebraska Democratic Party, county parties and candidates' campaigns within District 1, 2, and 3, respectively. An award is given to one volunteer per Congressional District.

Anne Boyle Young Democrat Award

- Was called the JFK Award
- Nominees for this award should be a young person (using the age criteria of the Young Democrats which is under 35-years-old) honored for their exceptional volunteer activities and participation within the Nebraska Young Democrats and the State Party.

Frank LaMere Hall of Fame Award

- Was called the Hall of Fame Award
- Nominees should be an elected County Party officer or elected State Party
 officer or an elected official who are dedicated to the principles of the Nebraska
 Democratic Party and who have contributed above and beyond the call of duty to
 the Nebraska Democratic Party along with local issues that impact the state and
 national level.

Ben Nelson County Party Volunteer Award

- Was called the Morrison-Exon Award
- Nominees should be a County Party volunteer who has worked tirelessly to
 promote the activities and values of the Democratic Party in their county.
 Nominees should demonstrate a dedication to service, integrity, the organizing of
 their county party infrastructure, and support for local Democratic candidates.
