## **Resolutions for Consideration**

## 1) Resolution from the Rural Caucus commending Chair Jane Kleeb

The Rural Caucus of the Nebraska Democratic Party,

Believing, That a strong rural base in the Democratic Party is crucial to developing a strong national Democratic Party;

Believing, That the Heartland States are critical to the strong rural base of the Democratic Party; and

Believing, That State Chairs are a significant source of leadership in this effort; therefore

Commends, Chair Jane Kleeb for her efforts to rebuild the Nebraska Democratic Party;

Commends, Her support of the rural Democrats in Nebraska and the Rural Caucus of the Nebraska Democratic Party; and

Commends, Her for the time and effort she spent to address the Regional Rural Conference in Topeka Kansas on October 19<sup>th</sup>, where her speech was well received by those in attendance.

# Information on the Delegate Selection Plan (DSP)

The DNC gave final approval for our Delegate Selection Plan. The document lays out the basics of how we choose delegates for the National Convention.

We will send 33 delegates to Milwaukee, WI for the National Convention.

Four of those delegates are "automatic" which are four of our statewide officers—Jane Kleeb Chair, Richard Register First Assoc. Chair, Patty Zieg DNC Committeewoman and Ron Kaminski, DNC Committeeman.

If new officers are elected at the 2020 State Convention, the current officers are still the automatic delegates to the National Convention. Any possible new Chair or

Associate Chairs do not resume office until December 2020. Any possible new DNC Committeeman or Committeewoman resume office the day after the National Convention. Incoming officers do not get passes to the convention unless they run for delegate.

The other 29 delegates, of our 33 member delegation, will be voted on at the State Convention.

The Rules Committee is currently working on draft county convention rules for the SCC's consideration at the January meeting which will be published in the Day of Agenda.

## **Key Dates and Information for DSP Process:**

County Party deadline to inform the NDP on where and when their county convention will be held is Feb. 14, 2020. Please email <a href="mailto:info@nebraskademocrats.org">info@nebraskademocrats.org</a> with the date and location.

Forms for use by the counties during the delegate process and other next steps will be published on the DSP blog by Feb. 24, 2020. All other forms for the delegate process become public on the NDP website in May.

County Conventions will be held May 14-24 (counties must inform the NDP of their space and date by Feb 14 so we can ensure its accessible, good size and so we can determine counties we may need to hold a convention for).

The State Convention, June 5-7, 2020, will be held at the Omaha Marriott Downtown.

The National Convention, July 13-16, 2020, will be held in Milwaukee, WI. The Nebraska delegate hotel is in Rosemont, IL along with FL, CA, TN, WA, Guam and the Virgin Islands.

# **Party Reform Committee Report**

# Proposals to Rules Committee and State Central Committee Initially presented to the SCC, Dec. 7, 2019

The next steps in bringing these ideas to policies, will be for the Rules Committee to turn these into proposals for discussion and vote at the State Convention.

We presented these ideas first at the December 7 SCC phone meeting and will discuss at the SCC meeting in Norfolk. Votes will not happen on these ideas/proposals until the State Convention.

## • State Central Committee Membership

- Keep current LD structure for the election of State Central Committee members.
- Add 20 gender balanced at-large seats, appointed by the Executive Committee to ensure regional, ethinic and racial diversity in our body.
  - 4 Tribal Members of each Sovereign Nation in Nebraska (Ponca, Santee, Omaha, Winnebago) that are elected by their Tribal Councils.
  - 5 County Chairs.
    - Must be from underrepresented areas with a focus on rural counties.
  - 5 Young Democrats (under the age of 35).

6 from diverse communities to bring fuller representation to the SCC.

#### Statewide Officers

- First Associate Chair changes name to Vice Chair.
- Vice Chair of County Parties (also a name change) elected by the County Chairs (replacing the Chair of Chairs seat).
- Chair, Vice Chair and Vice Chair of County Parties serve 4-year terms (versus 2-year terms) starting their term of service in 2023 (with election of these officers for the new term in 2022).
  - Elections for these three positions to be held in midterm-years at State Convention rather than Presidential years, starting in 2022.
  - Elections for DNC Committeeman and Committeewoman will remain in Presidential years at State Convention. The terms remain 4-year terms.
  - After the regularly scheduled leadership elections, the new officers takes office the day after the general election of that year instead of at the next SCC meeting after the election.
- CD Associate Chairs become Vice Chairs in name also to be consistent with statewide office name change.

#### Vacancies

- If a vacancy occurs, there must be at least 30 days before an election is held.
- If something happens to both Chair and Vice Chair, the Second Associate Chair/Chair of County Parties becomes acting Chair until the election at least 30 days after the vacancy.

## Conflicts of Interest

- Statewide Officers cannot hold elected office, or run campaigns, or run for office while serving their term.
- NDP staff cannot hold elected office, or run campaigns as a paid staff member to the candidate, or run for office.
- The NDP's expectation is these rules of state party staff and officers also applies to any county with large resources in order to avoid conflicts of interest and promote fairness among candidates. It is up to each county to adopt or not adopt this rule.
- Our Code of Conduct and Fairness Resolution are still part of the NDP policies.

#### Caucuses and Councils

- Caucuses with members that have immutable characteristics and the Chair of the Caucus SEC.
  - This includes: Womens, Black, Latinx, Native, Stonewall Democrats and Young Democrats.
- Councils are for issue-based members and the Chair of the Council gets a seat on the SCC (but not the SEC).
- Councils and Caucus do not have to re-apply for their charters to be recognized under these new rules.
- Caucuses and councils must submit a biennial report about their past year accomplishments and their plans for the next biennial period along with their biennial submission of their bylaws and officers.

**Resolutions Committee Submissions:** If you want to submit a resolution for consideration, please contact the Resolutions Chair Shirl Mora James by email sa@morajameslaw.com.

- Any proposed resolution must be submitted to the Resolution Committee Chair 10-days ahead of the SCC meeting (therefore for this meeting the date is January 7th, 2020 at Noon CT).
- The committee then reviews and votes on resolutions. The committee can take 3 actions.
  - 1) We can approve the resolution out of committee (as is or with some suggested edits) and bring to the floor of the SCC for a vote. We will hand out the proposed resolutions for SCC consideration in a packet at the Registration desk.
  - 2) We can reject a resolution and we will inform the submitter of this decision. A SCC member can then bring the resolution to the floor with a majority vote of the body to hear the resolution.
  - 3) We can recommend the resolution to a committee for the State Convention.

 Research the resolution's topic. Make sure what you want to propose does not conflict with the Platform and other passed Resolutions.

- The Platform Committee needs to receive a writable document (non-PDF, non-hard copy) sent to one or both designated email addresses, even if the resolution comes from the floor.

 Please be sure to designate who will present the Resolution and speak in favor of it, if you are unable to attend the meeting.
