The DNC gave final approval for our Delegate Selection Plan. The document lays out the basics of how we choose delegates for the National Convention.

Nebraska will send 33 delegates to Milwaukee, WI for the National Convention. Four of those delegates are "automatic" which are the statewide NDP officers—Chair Jane Kleeb, First Assoc. Chair Richard Register, DNC Committeewoman Patty Zieg and DNC Committeeman Ron Kaminski. The other 29 delegates will be voted on at the State Convention (June 5-7 in Omaha).
