# State Central Committee Meeting January 28-30, 2022 30-Day Agenda Packet

The Nebraska Democratic Party looks forward to “seeing” all the SEC and SCC Delegates along with County Chairs, Candidates, Elected Officials and grassroots Democrats at our Council, Caucus and SCC meetings.

***All of the meetings, Jan 28-30, for the State Central Committee will be held online.***

*Before we get into the 30-Day Packet, we want to flag **critical information** about County Conventions and an election to be held at the January meeting for an Officer vacancy.*

***It is important that you read the next two sections***

### ➔ **County and State Convention Dates**

As per the 2022 Calendar adopted as amended at the SCC meeting held on October 3, 2021, the window to hold County Conventions will be from March 1-20, 2022. The State Convention will then be held from April 1-3, 2022.

#### **County Conventions:**

- **Dates:** March 1-20, 2022
- **Location:** Each of the 93 counties

#### **State Convention**

- **Dates:** April 1-3, 2022
- **Location:** Hastings
- **Training:** VAN and Summer organizing techniques and tools
- **GOTV:** Calls and texts to prepare voters for their Vote By Mail Ballots and a push to get voters to return their VBM Applications (early voting starts April 11, 2022)
- **Featured APO/APC:** Youth Assembly
- **Notes:** Speeches by statewide candidates will be in-person, all others will be by video in consideration for them needing to be focused on GOTV and not drive time.

Additionally, all Convention Delegates will participate in a phone/text bank bringing an additional 200+ volunteers to GOTV efforts.

## ➔ Vice Chair Vacancy and Election Information

Given the resignation of Vice Chair Spencer Danner, we will elect a replacement at the January SCC meeting. **This is the 30-day notice.**

Those interested in serving in the role can submit their name to the nominations Chair Roger Morgan at [nominations@nebraskademocrats.org](mailto:nominations@nebraskademocrats.org). Nominations in order to be included in the 10-day packet must be submitted by Jan. 19 at noon. Nominations may be submitted from the floor. The term of service for this office is from Jan. 29 until the day after the November elections.

Those interested in service as Vice Chair must be a registered Democrat living in Nebraska, they can not currently hold an elected office and must be of opposite gender of Chair Jane Kleeb.

We will vote on the new Vice Chair at the SCC Meeting on Jan. 29. Individuals will be able to have 2 nominating speeches at 1 minute each and then give a speech themselves for 5 minutes.

Spencer's letter to the SEC and SCC is below:

**Resolutions Committee Submissions:** If you want to submit a resolution for consideration, please contact the Resolutions Chair Shirl Mora James by email [platform@nebraskademocrats.org](mailto:platform@nebraskademocrats.org)

- Any proposed resolution must be submitted to the Resolution Committee Chair 10 days ahead of the SCC meeting (**therefore for this meeting the date is Jan. 18, 2022 at 1 p.m. CT**).
- The committee then reviews and votes on resolutions. The committee can take three actions.
  1. We can approve the resolution out of committee (as is or with some suggested edits) and bring it to the floor of the SCC for a vote. We will hand out the proposed resolutions for SCC consideration in a packet at the Registration desk (for online meetings they are included in the 10-day packet, and the day-of agenda).
  2. We can reject a resolution and we will inform the submitter of this decision. A SCC member can then bring the resolution to the floor with a majority vote of the body to hear the resolution.
  3. We can recommend the resolution to a committee for the State Convention.

### **Tips and Tricks for Submitting a Resolution to the NDP:**

- Research the resolution's topic. Make sure what you want to propose does not conflict with the Platform and other passed Resolutions.

- Write your resolution to be free of spelling and grammatical errors. Shorter resolutions are better. Whereas paragraphs should be descriptions. The resolved paragraph sets out the actions you want taken.
- The Platform Committee needs to receive a writable document (non-PDF, non-hard copy) sent to one or both designated email addresses, even if the resolution comes from the floor.
- Please be sure to designate who will present the resolution and speak in favor of it, if you are unable to attend the meeting.
